Keep it In the Ground  
Organized the Fossil Free KC campaign to win a moratorium on all new, major fossil fuel infrastructure in King County. This included approximately 25 campaign team meetings to co-create the campaign with volunteer leadership, and hosted 6 meetings for the general public that reached approximately 100 participants. Organized the No LNG campaign, where held monthly community events that educated hundreds of community members across the Puget Sound region about the dangers of fracked gas and the proposed Tacoma LNG facility. Culminated in organizing 700 people to attend Puget Sound Clean Air Agency hearing in opposition to the facility. Organized the No Methanol campaign which generated hundreds of comment letters. Organized 3 delivery actions for these letters at Dept. of Ecology offices across Western WA.

Movement Building  
In March and April of 2018, the Pledge team held a training series attended by over 100 people to educate volunteers on how to engage in and amplify direct action. Held a new volunteer orientation that brought in 150 new volunteers, and throughout the year grew the volunteer base through dozens of outreach events including social hours, book clubs, house parties, and tabling in stores and at community events. Helped increase attendance and provided speakers and support for youth-led climate initiatives like Zero Hour Seattle and the Sunrise Movement, and other movements including reproductive justice, immigrant rights, economic justice.

Community Solutions  
The Housing team drove hundreds of comments, regular turnout and testimony for new Accessory Dwelling Unit (ADU) legislation at the City level, and convened a small coalition for a housing forum, attended by hundreds. After months of research and 6 "listening circles" for tech workers, the Amazon team supported Amazon tech workers to file a shareholder resolution and engage in press outreach for the story. The transportation team drafted comment letters for, and testified at, dozens of city council and city committee meetings, advocating for green transportation legislation. The team supported other movements for transportation justice, including the UW Pass or Fail campaign, and helped establish the new Move All Seattle Sustainably coalition which changed the dialogue around transportation needs in Seattle via multiple letters to the Mayor and Council and public press releases.
